

Suggestions for Pastoral Response to Disclosure of Sexual Abuse or Assault

Stay calm and listen well (James 1:29-30).

Turn to proper legal authorities (Romans 13:1-5) and avoid taking the role of the investigator.

Operate with a commitment to protect the weak and vulnerable (Exodus 22:22).

Prioritize care for the victim. Seek safety for those in harm's way (Psalm 10:11-15).

If sexual abuse is disclosed to you

What is disclosure? Disclosure is when a child/adult tells another person that he/she has been sexually abused. Disclosure can be scary and a difficult process for anyone. It may take someone who has been sexually abused weeks, months, or even years to fully reveal what was done to them.

During & After Disclosure:

Your reaction to the disclosure can have a positive or negative effect on how the victim deals with the trauma of sexual abuse. Victims who have a supportive caregiver/support system are more likely to begin the healing process quicker. To be supportive, we suggest you:

- **STAY CALM** Hearing of abuse can bring up powerful emotions, but if you become upset, angry, or out of control, this will only make it more difficult for the victim to disclose.
- **LISTEN & SUPPORT** Do not express doubt or disbelief to the person. Encourage him or her for his or her courage in sharing with you and assure him or her that you are taking the claims seriously.
- **PROTECT** the child/victim by getting him/her away from the abuser if needed. If you are working with a minor, immediately report the abuse to local authorities (see **MANDATORY REPORTING** requirements below). If you are working with an adult victim, the victim can choose whether to pursue legal action. If you are unaware who to contact, you can call the Child Help National Child Abuse Hotline at 1-800-4.A.CHILD (1-800-422-4453) or <https://www.childhelp.org/national-and-local-impact-map/mississippi/> or for immediate help call 911.
- **GET HELP.** In addition to getting medical care to address any physical damage, if needed, the victim may need to talk to a mental health professional who specializes in abuse/trauma. Professional mental health therapy has shown to be successful in assisting in coping with trauma from abuse both in the victim and the family unit. Many communities have Children's Advocacy Centers (CAC) that offer coordinated support and services to victims of child abuse. - **REASSURE** the victim that they are cared for, but don't make promises you can't keep. For example, do not tell a victim who is a minor that you will not tell anyone about the abuse. Rather, let the victim know you will do everything in your power to protect him/her from harm.

MANDATORY REPORTING - Per **Miss. Code Ann. § 43-21-353**: "Any attorney, physician, dentist, intern, resident, nurse, psychologist, social worker, family protection worker, family protection specialist, child caregiver, minister, law enforcement officer, public or private school employee OR ANY OTHER PERSON having reasonable cause to suspect that a child is a neglected child or an abused child, shall cause an oral report to be made immediately by telephone or otherwise..." ***Therefore, the above stated suggestions are not in lieu of your legal duty to report to Mississippi's Department of Child Protection Services if you have reasonable cause to suspect child abuse (sexual or otherwise) or neglect. 1-800-222-8000 or <https://reportabuse.mdcps.ms.gov/>***
